***INFORMATION REGARDING YOUR 2025 STATEMENT OF ECONOMIC INTERESTS  
FILING***

Dear Filer,

Your name has been submitted to the Will County Clerk's Office, by the unit(s) of local government with which you are affiliated, as being required to file a 2025 Statement of Economic Interests. You can complete this requirement by utilizing our online filing system.

To log in, you will once again need your Filer ID#.

Your password is the unique password that you used when completing your Online Filing in 2024. If you cannot locate your password, click the "Forgot your password?" link below the log-in box.

Once logged in, the system will ask you to confirm or update your e-mail address and create a new password for access to the system in 2025 (Step 1), verify your contact information (Step 2) and confirm the unit(s) of government with which you are affiliated (Step 3).

You can then proceed to submit your answers for each question on the Statement of Economic Interests (Step 4). Once you have answered all the questions you will be able to verify your answers and submit your Statement (Step 5). A confirmation page will appear, which you can print for your records. You will also receive a confirmation email. **Please be sure to complete Step 5 – your filing is not complete until you "Submit Statement" and receive your on-screen confirmation.**

Please keep the following in mind:

- The filing deadline is May 1<sup>st</sup>, 2025. Late filings are subject to a statutory \$15 late filing fee and must contact our office for instructions on how to file after the deadline. Failure to file within the time prescribed may result in

forfeiture of position.

- The mailing address listed is required to be your residential mailing address – NOT the address of a business or a unit of government's office.
- If you are no longer affiliated with a unit of government listed for you, please contact our office immediately so that we may adjust your filing requirement accordingly.
- For each of the 7 questions, you must either provide information in each required field **OR** check the box to indicate "The answer to this question is None."

We have created a helpful, step-by-step guide for using the Online Filing System, complete with screenshots to help you track your progress. We strongly urge you to open this guide in a separate tab before accessing the system.
