Dear Three Rivers Division Member:

The two-year term for all current Three Rivers Division officers will expire at the June 3, 2025 Governing Board Meeting.

**The Division is seeking three members to comprise the Three Rivers Division Nominating Committee.**

Per the Division Bylaws (Article VI, Section B):

A Division Nominating Committee comprised of three school board members from Active Member school boards shall be appointed by the Chair and shall present a slate of officers to the Governing Board. *\*Please note that the nomination process and the recommended final slate of officers will not hinder a Governing Board member from nominating other members for candidacy at the Governing Board meeting.* Additional nominations may be made from the floor, providing the nominee is present and consents to his/her nomination.

Any Three Rivers Division member who is interested in serving on the Nominating Committee should know that:

- Once selected, the Nominating Committee will designate dates and times of future meetings that committee members must attend.
- The Division Nominating Committee shall not nominate one of its members.

The first three members who meet the above criteria, provide the requested information, and are available for the scheduled Nominating Committee meeting dates (this will be confirmed upon receipt of the inquiry), will be considered for membership on the Three Rivers Division Nominating Committee. Once three members have been assigned to the Nominating Committee, consideration will be closed. Please note that this may lead to the process being closed prior to the due date for submitting an interest. In the event a selected member cannot serve, later responders will be selected to fill any vacancy based on the order their reply was received.
