NEW SCHOOL PLANNING

Superintendent Hess provided an update on Gene Dillon Elementary School including a construction update, the upcoming Dedication Ceremony on September 12, 2018, and the school mascot which will be the American Bald Eagle. No action was taken.

EQUITABLE STUDENT ACHIEVEMENT

Bemidji Area Schools Demographics

Kathy Palm, Director of Curriculum and Administrative Services, reported on the 2017-2018 District Demographics including: Poverty, Special Education, LEP, Ethnicity, and Homeless populations. No action was taken.

Minnesota Comprehensive Assessments (MCA) Update

Kathy Palm, Director of Curriculum and Administrative Services, reported the school district started MCA testing the first week in April and will continue until the second week in May. The district expects to administer 6,578 MCA tests this year. No action was taken.

McKinney Vento Homeless Education Assistance Funding Update

Superintendent James Hess informed the School Board that the McKinney Vento Homeless Education Funding was being eliminated. He has asked the Minnesota Commissioner of Education to consider re-distributing these funds. No action was taken.

RELATIONSHIPS/COLLABORATION

Extension of Lease for Ball Fields with Beltrami County

Superintendent James Hess informed the School Board that the district recently extended the lease with Beltrami County for the ball fields located by Bemidji Middle School for another 15 years. No action was taken

HIGH QUALITY DISTRICT

Potential Reductions and Additions in Programs and Positions

The motion was offered by Jeff Haack, seconded by John Gonzalez, and carried by all in attendance, to remove .50 FTE Social Worker (Homeless Program) from the list of potential reductions and remove .5 FTE Elementary Principal from the list of potential additions.

John Gonzalez moved to withdraw his second to the previous motion. Therefore the original motion died due to lack of a second.

A motion was made by Shawn Whiting, seconded by John Gonzalez, to amend the motion to approve a 1.0 FTE Social Worker position to the list of potential additions.
