9. Teacher Licensure – CONTINUE	Ark. Code Ann. §§ 6-17-902 6-17-919 Standard 4-D.1	I believe that 6-15-1004, 6-17-309 and 6-17-401 were listed in your initial application. You would need waivers of these code sections, as well. You would also need to add the DESE Rules Governing Educator Licensure, Section 7.
