BACKGROUND INFORMATION:

High School Fine Arts Upgrades (including a new band hall) and Cafeteria Additions & Renovations was approved to be constructed as part of the voter approved MAY 2023 BOND ELECTION.

On September 2023, the district acquired Rawley McCoy & Associates (Architects & Interior Designers) as the architectural firm to design the new construction project. Since then, the district has collaboratively worked with all necessary stakeholders to design the new facility.

At the September 23, 2024 Board meeting, Administration recommended and the School Board awarded, Weaver & Jacobs Constructors, Inc. and gave the Superintendent the right to negotiate a contract, not to exceed, \$25,500,000 and a 24-month completion time. Administration met and negotiated with Weaver & Jacobs to plan an expedited timeline and save costs in the process.

RECOMMENDATION:

The committee will present a recommendation to the board of trustees with the negotiated cost of construction and reduced timeline at the regular board meeting.
