TITLE: Approval of Out of State Travel

BACKGROUND:

STUDENTS

Approximate cost of the travel is \$1,280 and will be paid for by tax credits, gifts and donations, and student activity funds. One school day will be missed and a substitute is required.

Tim Berrier, Paul Vasquez, and Steven Montaño from Ironwood Ridge High School request permission to take 16 students from the Varsity Wrestling Team to Las Vegas, Nevada, December 19-22, 2013. Approximate cost of the travel is \$2,750 and will be paid for by tax credits and student activity funds. No school days will be missed.
