## **Under Agenda Item #6: Administrative Reports**

A. Support Services – Preston Lindsey

Curb work on the roof air conditioner unit has been completed and the twenty year warranty for the work was confirmed. The new scoreboard was installed last week and worked well at the games. Planning for the possible future construction, the district will be submitting Request for Proposals (RFP) for Construction Manager at Risk to oversee the anticipated bond construction.

Mr. Lindsey recommended purchasing from Hall Buick GMC, who came in with the lowest bid. Ty Lindsey made a motion to approve the recommendation to accept the bid from Hall Buick GMC to purchase a

2026 Chevrolet 3500 single axle crew cab gasoline engine truck for \$50,700, and the 2026 Chevrolet nine passenger Suburban for \$59,500. The motion was seconded by Jake Howard. All members voting in favor: Shane Jasper, Vic Bansal, Jake Howard, Ty Lindsey, Homer Dickey, Lisa Lewis, and Todd Kelly.

#### **Superintendent's Discussion Items**

Superintendent Jones informed the Board of the great turnout for Grandparent's Day at the Elementary campus. Homecoming activities are scheduled for next week. Senior readers and greeters will come to the elementary campus on game day Fridays. They assist with greeting the younger students as they arrive on campus and also enter the classrooms to read and interact with the children. To comply with one of the many legislative changes, the district has been searching for a software system that would interact with Skyward to track and inform parents of library selections made by their student. After a testing period this week, Follett was found to interact correctly and test notifications were sent. The board meeting date in October is tentatively set for October 27<sup>th</sup>. After the regular board meeting, the board and possibly the Arp ISD Board of Trustees will stay for required legislative updates and Team of Eight training. Superintendent Jones will confirm with the trainer and notify the board.
