Seek approval for the purchase of ggCircuit to manage and maintain the Rec Center's Esports computers and games available to students.

Justification:

The REC Center's Esports venue is a one-of-a-kind venue for our students and community. GgCircuit provides leading software to manage a venue just like this. ggCircuits management services allows our IT Department to give every user the same experience. This system allows specific images which include all the correct configurations to all computers including the games available to be played through one user portal. In addition, it can control specific images or instances for students to use after hours booking time in the room on specific computers.
