Funding from the state based on student enrollment. Estimated numbers for the district was 177 students. Currently, there are only 168 students enrolled. They are working on a number of grants. Two schools not meeting student estimate budgets. They have to make difficult decisions. However, there are a number of grants that are in the works. Some attempts to gain some income are as follows: renting the Café to Roxy and potentially selling the Float House. Some unexpected expenses that have come up: Cross Country team went to state. Discussion about the Greenhouse: Some cuts come from cutting the utilities, about \$1,000 per month. Our Americorps person is gone, our part-time employee is gone, Megan's position may be funded under another grant, but that remains to be seen. However, we cannot function with a production-sized facility.

Another topic of discussion is the potential relocation of the weight room to the old "Kindergarten" building.
