3) Public Input:

There was no Public Input.

4) Reports and Communication:

A) Art Teacher Presentation

Hartwell introduced an ALEX student who is very involved in his artwork. The student spoke about his abstract artwork, and answered questions from Board and staff members. Robicheau asked about potential spaces outside of CVSEC for displaying student artwork. Hartwell replied there are spaces at The Paradise Center for the Arts, The Northfield Arts Guild, and CVSEC is looking into a possible space just outside the interior Cooperative mall entrance.

B) Executive Director's Report

CVSEC now has a live social media presence on Facebook, Twitter, and Instagram. There have been lots of posts and all are being well-received. The Cooperative held its spring open house last week for current families and caregivers. Tomorrow there will

be an open house for incoming STEP students. CVSEC currently has five open teacher positions, thirteen open EA positions, and one open Intervener position. Interviews continue. Summer projects include a delayed egress system being installed. SUN and ALEX Extended School Year ("ESY") will be the last two weeks of July, M-F 8:30 – 1:30.

C) Enrollment Report

CVSEC currently has 84 students. Referrals on our list for ALEX and SUN are being accepted into the program now rather than in the fall, as it makes for a smoother transition for students.

6) **New Business:**

A) 2023 – 2024 Preliminary Budget Presentation

McGuire reminded the Board that all MN school districts are waiting for the Legislature to settle on a budget while keeping a close eye on the mandates that will be tied to increased funding. Washa said that, given what McGuire said, this is a very preliminary budget and she expects revisions will be made. Salaries and wages were based on CVSEC being able to fully staff all positions; benefits also increase accordingly. Purchased services increase due to contracted services that are purchased if positions go unfilled. Other revenue sources are based on prior year calculations. Grants drop to zero from last year due to the expiration of Covid grants. Lease levy amounts for each member district are based on the December 1st child count. Tuition billing projects are based on the percentage of member district students enrolled at this time. This can change as students are enrolled and transition back to home districts. Robicheau asked about formal documentation for the repayment schedule of the \$1M loan to member districts. McGuire will work on a policy to formalize repayment over the summer. The Preliminary Budget will be approved at the May, 2023 meeting.
