**Subject: Permission for Cut Bank School Buses to Enter District 9, Route 1 Sweetgrass 2020-2021**

**Description:** Cut Bank bus enters District 9 on this route to pick up students who attend school in Cut Bank, MT. Route 1 is The Sweetgrass route (Reagan Field) that comes approximately 25 miles into our district on the old Croff Wren road. Financial cost is shared between county and state (1/2 each) and payment

**Financial Impact:** Cut Bank is the nearest operating bus route in the Reagan Field area. It is more cost effective for Browning Schools to offer an individual transportation contract to families in this area. We do not pay the individual transportation cost to the students who ride this route.

**Funding Source (Budget/grant, etc.):** Financial cost is shared between County and State.

Mylee Barry, Logan Dell, Bauer Seewald, Brant Seewald


We have been operating this route in your district for many years and we appreciate your cooperation in this matter.
