The meeting was called to order by the President and, upon the roll being called, the following members of the Board of Education answered present:

The President reported that a proposal had been received from Apple, Inc. to enter into Schedule No. 4 to the Master Lease Purchase Agreement dated July 7, 2017 whereby the District leases computer hardware pursuant to Section 10-22.25a of the *School Code*, and the Board of Education would consider adoption of a resolution providing for the approval of such Master Lease Purchase Agreement.

Whereupon, Member ______ presented a resolution as follows:

RESOLUTION authorizing and approving Schedule No. 4 to the Master Lease Purchase Agreement Dated July 7, 2017 in connection with the lease of computer hardware for Oak Park Elementary School District No. 97, County of Cook, State of Illinois.

WHEREAS, it is deemed advisable, necessary and in the best interests of School District No. 97 (the "District"), County of Cook, State of Illinois, that computer hardware as described on Schedule No. 4 (the "Property") be leased for the District, all in accordance with the specifications therefor reviewed by the Board of Education of Oak Park Elementary School District No. 97 (the "Board"), and on file with the Secretary of the Board; and

WHEREAS, the District has the power to obtain personal property, when authorized by an affirmative vote of 2/3 of the members of the Board, by lease with an option to purchase for a period not to exceed five years, pursuant to the provisions of Section 5/10-22.25a of *The Illinois School Code* of the State of Illinois, as amended; and

WHEREAS, it is necessary that the District avail of the provisions of said Section 5/10-22.25a in order to obtain the Property by means of a lease-purchase agreement; and

WHEREAS, Apple, Inc. (the "Lessor"), has agreed to lease the Property to the District pursuant to such an agreement on terms which are lawful and acceptable to the Board;

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of Oak Park Elementary School District No. 97, County of Cook, State of Illinois as follows:

<u>Section 1.</u> <u>Incorporation of Preambles</u>. The above preamble recitals are hereby incorporated into the text of this Resolution as if set out herein in full.

<u>Section 2.</u> <u>Authorization of Lease Agreement</u>. The Board hereby finds and determines that it is in the best interests of the District to enter into, and does hereby approve, pending final legal review and approval, entering into Schedule No. 4 to the Master Lease Purchase Agreement dated July 7, 2017 with Apple, Inc., in an amount not to exceed \$1,200,249.68 for the purpose of financing the costs of the acquisition and installation of the Property, which was presented to the Board at this meeting, a copy of which is attached to this Resolution as <u>Exhibit A</u> and is made a part hereof.

<u>Section 3.</u> <u>Execution of Lease Agreement</u>. The Superintendent of Schools or her designee is hereby authorized and directed, following legal review and approval, to execute the Schedule No. 4 to the Master Lease Purchase Agreement dated July 7, 2017, and to do all things necessary and

essential to effectuate the provisions of the Agreement, including the execution of any documents and certificates incidental thereto or necessary to carry out the provisions thereof.

<u>Section 4.</u> <u>No Conflict of Interest</u>. It is hereby found and determined that no person holding any office of the District, either by election or appointment, is in any manner interested in Lease Agreement, either directly or indirectly, in his own name or in the name of any other person, association, trust or corporation.

<u>Section 5.</u> <u>Designation as Qualified Tax-Exempt</u> <u>Obligations</u>. The Board hereby designates the Master Lease Purchase Agreement as a Qualified Tax-Exempt Obligation pursuant to Section 265(b)(3)(B) of the Internal Revenue Code of 1986, as amended, and authorizes the Business Manager of the District to execute appropriate certifications in connection therewith.

<u>Section 6.</u> <u>Repealer and Effective Date</u>. All resolutions or other proceedings in conflict herewith are, to the extent of such conflict, hereby repealed, and that this resolution be effective forthwith upon its adoption.
