4. RECOGNITION, AWARDS, PRESENTATIONS, PUBLIC HEARINGS

4.1 Update on Vision for Learning & Teaching

Dr. Andy Barrett gave the Board an update on the vision for Learning and Teaching. A video called "A Shifting Paradigm" was shared with the public a couple of weeks ago showing how we want our students to be self-directed, lifelong learners; effective communicators; complex, creative and adaptive thinkers; and collaborative and productive citizens. He shared with the Board four questions that he asked them to answer as quickly as possible. The key ideas were that content has never been the only goal of schooling, and that a changing world demands that we consider how to support our students beyond the content. The quickest way to get the answers to the questions presented would be to pull out our phones and google the answers. Our paradigm is changing, and it's not just

Geneva that is going in this direction. Dr. Barrett talked about the seven survival skills of 21st Century learning, and he touched on each one of the goals and how they should affect our students. You can expect ongoing communication, the disequilibrium of new learning and paradigm shifts, students and teachers stepping out and trying new things, and a lot of great stuff!

Board comments, questions, discussion: How do we know when we get there? (That's a good question. It will be a challenge. This is a continual process. We will identify levels of progress and achievement.)

5. SUPERINTENDENT'S REPORT (Policy 1210)

The Superintendent reported that there is a lot going on this week, as it is Homecoming. Students have been downtown painting windows and working on floats. He gave a reminder that the pep rally and BBQ will be Thursday evening, with the parade and game on Friday, and the dance on Saturday. We have no information on the PARCC at this time, and there is no annual State report card. We really don't have data to rely on from the past, so we are using our MAP tests. Hopefully, the State will keep the ACT exam, as it is one data piece we rely on. Our scores were not included in the State PARCC summary, because our students tested with paper and pencil. There is also a State law that indicates principals must set their goals by October 1st, and these meetings have been held. These are exciting meetings, where we collaboratively discuss the educational direction of our building leaders for our students. Our Communication Coordinator, Kristy Poteete-Kriegermeier, and our Communications Task Force have been doing a lot this year. This work includes our Facebook page, and Mill Creek recently launching their page. You will be seeing more Facebook pages created and updates on our websites in the next few months. We want the community to see where the tax dollars go for technology to educate our students, so we are planning a Board Forum and Technology Fair on October 27th, so please watch for information coming out on this.
