# OFFICIAL PROCEEDINGS OF THE ALPENA COUNTY BOARD OF COMMISSIONERS Full Board Meeting Minutes

April 27, 2021 1:00 p.m.

The Alpena County Board of Commissioners meeting was called to order by Chairman Robert Adrian in the Merchants Building at the Alpena County Fairgrounds on Tuesday, April 27, 2021 at 1:10 p.m. immediately following a Public Hearing which was called as a required component to close out and finalize the Community Development Block Grant received by Alpena County through the CARES Act. Minutes from that hearing are attached (#1).

#### **PRAYER**

Prayer was offered by Pastor Warren Hoffman of Huron Shores Fellowship in Alpena.

#### PLEDGE OF ALLEGIANCE

Board Chairman Robert Adrian called for the Pledge of Allegiance to the Flag of the United States of America.

#### **ROLL CALL**

#### PUBLIC COMMENT

Chief Bill Forbursh, Alpena City Fire/Alpena County EMS, and Andy Marceau, Community Risk Reduction officer, updated the Committee and those present regarding services available for community risk mitigation. Medical First Responder training is being planned as well as First Responder to EMT bridge-training. A paramedic program is being planned for fall 2021 at the Alpena City Public Safety Facility with another full session planned for June 2022. Monthly continuing education via Zoom is in its 6<sup>th</sup> month and will continue for first responders.

#### **UPDATE ON AIRPORT PROJECTS**

Steve Smigelski, Airport Manager, and Dave Joye, RS&H Representative, informed the Board the Airport has received \$17.9 million in CARES Act funding. An open selection process took place and RS&H was chosen to be the engineering consultant for the projects; they will also provide oversight. The CARES Act funding amount is based on financial reports over the past four years. The funds are to be used to offset operations and maintenance at the airport for the next 3-1/2 years. They are planning some major construction projects as sources of perpetual revenue. The Airport will utilize some of the funds to replace aging snow removal equipment and construct a number of private T-hangars. A corporate hangar is being planned which could also serve, if ever needed, as headquarters for an NTSB investigation and could also offer shelter during inclement weather for medical evacuation patients while being taken from the ambulance to the aircraft.

#### 2021 EQUALIZATION REPORT & RESOLUTION #21-07

Ted Somers, Equalization Director, presented to the Board the 2021 Equalization Report and Resolution #21-07.

### RESOLUTION #21-07 TO ADOPT THE 2021 COUNTY EQUALIZATION REPORT AS SUBMITTED

**WHEREAS**, the Equalization Department has examined the assessment rolls of the 8 Townships and 1 City within Alpena County to determine whether the real and personal property in the respective Townships and City has been equally and uniformly assessed; and

WHEREAS, based on this examination and studies it conducted, the Equalization Department has prepared and presented to the County Board of Commissioners the attached 2021 Equalization Report; and

WHEREAS, said Equalization Report presents recommended County equalized valuations for each of the 8 Townships and 1 City within the County; and

WHEREAS, the recommended County equalized valuations were determined by adding to or deducting from the assessed valuations of taxable property in the 8 Townships and 1 City within the County an amount which represents true cash value.

**NOW, THEREFORE BE IT RESOLVED,** that the Alpena County Board of Commissioners accepts and adopts the recommended County equalized valuations presented in the 2021 Equalization Report prepared by the Alpena County Equalization Department for a total 2021 equalized valuation of real and personal property of \$1,182,064,152 with the breakdown of equalized valuation by property classification as follows:

### RESOLUTION #21-08 SUPPORTING PASSAGE OF LEGISLATION TO ADOPT 4-YEAR TERMS FOR COUNTY COMMISSIONERS

Chairman Robert Adrian presented Resolution #21-08 for consideration.

#### RESOLUTION #21-08 SUPPORTING PASSAGE OF LEGISLATION TO ADOPT 4-YEAR TERMS FOR COUNTY COMMISSIONERS

WHEREAS the 1963 Michigan Constitution stipulated four-year terms for the county Board of Supervisors, the preceding body to today's Board of Commissioners; and

WHEREAS the Legislature voted in 1966 to abolish Boards of Supervisors and formally replace them with Boards of Commissioners after the 1968 elections; and

WHEREAS Public Act 261 of 1966 promulgated that the length of terms for the new county commissioners shall be concurrent with that of state representatives, as specified in Article IV, section 3 of the Michigan Constitution; and

WHEREAS the scope of duties of a county commissioner has greatly increased in the last century – road patrols, indigent defense, mental health treatment and substance abuse prevention programming, solid waste pick-up and disposal, food and water safety, park operations, economic development efforts, emergency management and response; and

WHEREAS Michigan is one of only five states in the United States that provides for exclusively two-year terms for county commissioners; and

WHEREAS all other county and township officials in Michigan are elected to terms of at least four years; and

WHEREAS the position of county commissioner is a highly complex oversight role that requires years to master; and

WHEREAS legislation to amend state law to enact four-year terms has been filed in the form of Senate Bills 242 and 245; and

WHEREAS the Michigan Association of Counties supports the legislation as introduced;

THEREFORE, BE IT RESOLVED that Alpena Cunty supports Senate Bills 242 and 245 to enact four-year terms for county commissioners.

#### **RESOLUTION #21-09 COUNTY REVENUE SHARING FUND**

Chairman Robert Adrian presented Resolution #21-09 for consideration.

#### RESOLUTION #21-09 COUNTY REVENUE SHARING FUND

WHEREAS, as the State of Michigan faced the great recession, they looked to find creative ways to save money in the State's general fund; and

WHEREAS, in 2004, a deal between county governments and the State of Michigan, created a property tax collection shift which would provide for revenue sharing funds to the Counties while not relying on the State's general fund for that; and

WHEREAS, during this time, the proceeds from the property tax collection shift was put in a County Revenue Sharing Reserve Fund whereby a county could obtain funds from there; and

WHEREAS, once a county exhausted their reserve fund, they re-entered the state revenue system where they should be receiving their full funding amount; and

WHEREAS, the Michigan Association of Counties has done extensive research into county revenue sharing and the impact the County Revenue Sharing Fund has had on county allocations and indicates that the State of Michigan has cumulatively shorted 60 counties of more than \$110 million between 2009 and 2014; and

WHEREAS, Alpena County is one of those counties, experiencing a shortfall of \$494,016; and a

cumulative shortfall of \$1,067,487 due to CPI increases being discounted after Alpena County's return to CRS; and

WHEREAS, it is time for those funds to be restored in full this year; and

WHEREAS, despite receiving federal funds through the state as part of the American Rescue Plan, the use of the federal funds is tied to COVID/pandemic related expenses; and

WHEREAS, while Alpena County has exhausted thousands of dollars related to the COVID-19 pandemic, we have budgeted services to provide to our citizens which are not related to COVID-19; and

WHEREAS, services provided by the Alpena County Courts, Prosecutor, Sheriff/Jail, County Clerk, Treasurer, Register of Deeds, Drain Commissioner, Administration and Alpena County Regional Airport are all funded in part by County Revenue Sharing and would be impacted by a restriction of funds for COVID only; and

WHEREAS, a portion of the revenue sharing also goes to support operations of other functions that requires an investment of local county matching funds to accept federal or state funded programs.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Alpena County Board of Commissioners calls upon state leaders to restore the County Revenue Sharing Fund and to provide a one-time payment of the cumulative shortfall.

- WHEREAS, the Northeast Michigan Council of Governments (NEMCOG) serves as the Fiscal Agent and Program Manager for the Northeast Michigan Community Corrections Advisory Board (NMCCAB), and
- WHEREAS, this County is a member of the NEMCCAB and strongly desires to continue to participate with Community Correction's Programs and Services, and
- WHEREAS, NEMCOG has worked with the OCC to develop a Community Corrections FY 2022 Grant Application for the NEMCCAB, and
- WHEREAS, the FY 2022 Community Corrections Grant Application has been Prepared by NEMCOG in the amount \$309,355 for Community Corrections Programs and Services in the counties of: Alcona, Alpena, Cheboygan, Crawford and Otsego, and
- WHEREAS, the Northeast Michigan Community Corrections Advisory Board, has approved this Grant Application, and recommends its approval by the member counties.
