Approximately 74.45% of the primary diagnosis behavioral services Driscoll offers in its facilities are provided to charity, self-pay, and Medicaid patients.
- ➤ Dedicated to our continued effort to improve the community's access to pediatric physician specialists. Driscoll credentialed 2 advanced practice professionals to the medical staff of its hospital.

Approximately 79.68% of all visits to Driscoll's emergency departments are made by charity, self-pay, or Medicaid patients.
- ➤ Driscoll recognizes that the state infant mortality rate exceeds 5% each year and the hospital is focused on reducing this rate by providing the latest in medical technology and specialized care to newborns across the region. Over 77.73% of neonatal intensive care services are to charity, self-pay, or Medicaid patients.
- Patients requiring psychiatric services are often one of the most under-served populations in a community, and Driscoll strives to ensure that these patients receive appropriate care. Approximately 78.59% of the primary diagnosis behavioral services Driscoll offers in its facilities are provided to charity, self-pay, and Medicaid patients.
- Dedicated to our continued effort to improve the community's access to pediatric physician specialists, Driscoll recruited 2 Pediatric Cardiologist and 1 pediatric Rheumatologist.
