Background Information

Each year, the board considers non-renewal of probationary teachers. This year's list is longer than typical years because of the number of Tier 2 teachers, number of teachers hired on an Out-of-Field Permission (OFP) from the State, the number of teachers hired this year due to COVID, and the need to reconcile the budget.

Please note the following:

- Reductions reflect full-time positions unless otherwise noted.
- Tier 1 and Tier 2 teachers must be non-renewed on a year basis.
- The administrative team may partially reinstate part-time reductions depending on the RWHS class schedule and needs.
- A position held by someone with an Out-of-Field Permission (OFP) position needs a 60-day posting for a renewal unless the Board of Teaching waives this requirement.
- The number of non-renewals does not match the number of positions being reduced because this list does not include teachers who retired, resigned, or transferred to other positions.
