Commercial General Liability insurance endorsoment providing coverage against claims for bodily highly or death and property damage occurring in or upon or resulting from the facilities licensed hereunder, such insurance to offer immediate protection to the limit of no less than \$500,000 and such insurance shall include Blanket Contractual Liability coverage which insurance contractual liability under the indemnification of the Parkrose School District #3 and PHSCC by Licensee as set forth below.

- 1: Licensee shall maintain a policy endorsed to include the Parkrose School District. Parkrose High School, school board members, agents, employees and volunteers as additional insured's as respects to the Organizations use of District facilities. Said insurance must be primary to and non-contributory with any insurance carried by the District and include waiver of subrogation in favor of the District, its board members, agents, employees and volunteers.
- Licensee agrees to provide all required certificates of insurance to the PHSCC Facility Coordinator at least fifteen (15) calendar days prior to the time of occupancy.
- 3. The parties agree that the specified coverage of limits if insurance in no way limit the liability of the licensee,
- Licensee shall provide a Certificate of Insurance containing a notice of cancellation clause not less than 30 days prior to cancellation or non-renewal of any such policy.

#### LAWS-RULES-REGULATIONS

- 4. All agents and employees connected with Licensee's use of the facility shall abide by, conform to and comply with all laws of the United States and the State of Oregon and all ordinances of the City of Portland. Oregon, and the rules and regulations of PHSCC, together with all rules and regulations of the Bureau of Police of the City of Portland.
- 2. THE USE OF ALL TOBACCO. ALCOHOLIC BEVERAGES AND CONTROLLED SUBSTANCES ARE STRICTLY PROHIBITED IN OR ON PHYCE PROPERTY.
- All security services including peer group security desired by Licensee shall be arranged for by special agreement with the PHSCC Facility Coordinator and shall be paid for by the Licensee.
- 4. The Parkrose High School shall have the sole right to collect and have custody of articles left in the building.
- Any decision affecting any matter not herein expressly provided for shall rest solely within the discretion of the PHSCC Facility
  Condinator.
