A motion to approve the request to submit the class size waiver for Canyon Ranch Elementary as presented was made by Nichole Bentley. The motion was seconded by Anthony Hill and passed 7-0.

A motion to approve the amendment of the Core Construction AIA A133-2019 Agreement to include a Guaranteed Maximum Price of \$8,820,231 for the Phase Two interior renovations and refresh of Coppell Middle School North and authorize Dr. Leanne Shivers or her designee to sign the necessary documents was made by Nichole Bentley and seconded by Ranna Raval. The motion passed 7-0.

Anthony Hill motioned to approve the amendment of the Core Construction AIA A133-2019 Agreement to include a Guaranteed Maximum Price of \$6,250,396 for the interior renovation of the auditorium at Coppell High School Ninth Grade Campus and authorize Dr. Leanne Shivers or her designee to sign the necessary documents. The motion was seconded by Leigh Walker and passed 7-0.

A motion to approve the amendment of the Core Construction AIA A133-2019 Agreement to include a Guaranteed Maximum Price of \$15,667,021 for the Career and Technology Education renovation and the New Tech High @ Coppell space renovation at Coppell High School and authorize Dr. Leanne Shivers or her designee to sign the necessary documents was made by Leigh Walker and seconded by Anthony Hill. The motion passed 7-0.

Jonathan Powers motioned to approve the amendment of the Core Construction AIA A133-2019 Agreement to include a Guaranteed Maximum Price of \$32,790,889 for the additions and renovations of Lakeside Elementary and authorize Dr. Leanne Shivers or her designee to sign the necessary documents and seconded by Ranna Raval. The motion passed 7-0.

A motion to approve the resolution as presented declaring a public purpose for the expenditure of district funds for employee pay to CHS employees for the date of November 12, 2025, was made by Anthony Hill. Jobby Mathew seconded the motion and the motion passed 7-0.

Nichole Bentley motioned to accept TASB Update 126 revisions to local policy and add local policy according to the instruction sheet for TASB Localized Policy Manual Update 126 affecting the following policies: BE, BED, CJ, CJA, CLE, CQ, CQB, CQD, CSA, DBD,
