

- 68% are first-generation



WHAT IS A BOND ELECTION?


- MHCC facilities are owned and maintained by local communities
- Colleges can borrow funding to pay for capital improvements
- Voters must approve these funds through a bond election on the ballot
- MHCC is putting a bond measure on the May 2025 ballot

- Outdated facilities systems are putting us at risk.
- Need for safeguarding MHCC as a community resource.



AN "ESSENTIALS" BOND PROPOSAL

FOUR ESSENTIAL PRIORITIES:

- 1. Improve Career Education Facilities to Meet Local Workforce Demand
- 2. Help MHCC Better Serve the Community
- 3. Secure the Campus
- 4. Repair Aging Facilities

Total Proposed Bond Measure: \$136 Million



1. IMPROVE CAREER EDUCATION FACILITIES

- Update existing classrooms and labs
- Establish a center for health
 professions on campus
- Modernize equipment for better training

Over the last five years, the college has trained nearly 1,000 healthcare professionals including nurses, surgical technicians, respiratory therapists, and mental health counselors.



2. HELP MHCC BETTER SERVE THE COMMUNITY




- Upgrades to the pool for year-round use
- Improved ADA accessibility
- New technology for urban and rural learners.

MHCC provided swim lessons to nearly 26,000 residents last year. The college operates the only outdoor competition-size pool in the Northwest and brings thousands of people to the community for swim meets and events.

3. SECURE THE CAMPUS

- Strengthen security
- Modern lockdown capabilities
- Upgrade fire safety systems
- Seismic retrofits for 50-year-old buildings

Living in the northwest, we all know the next big earthquake is around the corner. This bond will help MHCC prepare for the next big disaster, bringing buildings constructed with 50-year-old earthquake safety standards up to code and make the college a community emergency command and response center when disaster strikes.



4. REPAIR AGING FACILITIES



- Make large-scale repairs to 50-year-old buildings.
- Upgrade electrical wiring, heating and cooling.
- Repair crumbling siding and improve insulation.
- Replace outdated plumbing.

All buildings age and our college buildings are no different. The college has critical basic repair needs to major building systems that date back to the original campus. The bond allows us to make essential improvements that protect the community's investment in MHCC.

BOND MEASURE COST

Total bond proposal: \$136 Million

Estimated cost = 25 cents/\$1,000 of assessed value.

Average assessed house in district = \$5 a month
