## 2A. Superintendent's Report

- 1. All School Buildings were recently tested for radon. The number of samples collected were: Primary School 120, Intermediate School 87, Middle School 97, High School 134. All the samples were below the EPA action level of 4 pCi/L. So, all the schools are free of radon concerns. The tests will be conducted again in 5 years.
- 2. As we complete the first half of the 2018-19 school year, I congratulate administrators and staff members for the success our students have experienced thus far. The commitment of our administrators and staff make our schools amazing.

Our academic goal for this year is for students to achieve one year of growth in reading and math. Of the 16 grade levels tested by NWEA and MCA, 8 achieved our goal last year.

Mid-year math and reading testing for students was conducted last month. A review of data, academic standards, and instructional differentiation is underway. I am confident that we can achieve our goal for every grade level to attain one year of growth in reading and math this year.

# 3. Consent Agenda

The school board approves the resolution each February authorizing the administration to review all programs and positions in developing budget recommendations for the next school year.

4. The 2019 stakeholder input for strategic planning will again be conducted digitally using crowdsourcing technology. An outline of the process, pending approval by the school board, is below. I will discuss this in more detail at the meeting.

### Timeline:

- February 19 March 1: Idea submission from the stakeholder groups.
- March 12 18: Pairwise.
- March 19 21: Data processing by Optum.
- March 21 26: School board members assign the top 5 ideas from each of the stakeholder groups to an exit outcome area.
- April 1: School Board discusses placement of ideas into exit outcome areas.
- May 6: School Board begins discussing 2019-20 goals, based on the data.

- 2. What are we doing well at Becker Schools?
- 3. What could Becker Schools do better?
- 5. Kevin Januszewski will provide an overview of School Finance for Minnesota Public Schools.
