## MEMORANDUM OF UNDERSTANDING Fit Family Challenge 2021

This Memorandum of Understanding (MOU) is entered into by San Antonio Sports ("SAS") and South San Antonio ISD ("SSAISD") to fulfill the mutual obligations of the parties as set forth below for the 2021 Fit Family Challenge ("FFC") program.

## I. OBLIGATIONS OF SSAISD

- A. Provide access to a designated SSAISD school facility for a total of 12 FFC public events one per week beginning May 10 through August 6, 2021, excluding the week of July 5 9, 2021 for a period of two (2) hours per event.
  - i. Facility must have access to restrooms, be air conditioned and must include two separate areas to accommodate adult fitness class and youth Kid Fit class;
  - ii. One hour prior to the designated class time doors must be unlocked, rooms are set up and available for both adult and youth classes, and AC is on in both areas
  - iii. Restrooms must be available and unlocked
  - iv. One table, 2-3 chairs and trash cans available for check-in area
  - v. Day of class point of contact in case any issues arise; someone who is available at the school
  - vi. Provide access to a third designated areas at two classes with tables and chairs for health screenings
- B. Provide SAS with the dates, times and designated location(s) for the FFC events by March 26, 2021; Location: Dwight Middle School
- C. Distribute the FFC program information card, provided by SAS, to each elementary school within the district and use best efforts to send information digitally or by other means determined by SSAISD to middle & high schools within the district by April 30, 2021. The district agrees to notify San Antonio Sports by email the day following distribution of all materials
- D. Based on availability, provide marketing support through SSAISD communications including Robocalls, school marquees, website and social media;
- E. If necessary, provide SAS with COVID-19 safety measures required by the school district/facility

## II. OBLIGATIONS OF SAS

- A. Provide ongoing support to SSAISD to ensure the successful implementation of FFC and encourage attendees to participate in similar programs provided during the school year;
- B. Provide financial assistance for school district facility administrative costs (i.e., utilities, security, and/or janitorial fees) in the amount of \$1,000 to be paid upon receipt of signed Memorandum of Understanding;
- C. Provide snacks and beverages for weekly FFC events;
- D. Provide an incentive program that rewards participants for frequency of attendance at events, participating in health screenings (heart rate, blood pressure, glucose testing) and post program measurements and health screenings;
- E. Provide trainers/instructors for adults and kids participating in weekly events;
- F. Provide participants with FFC training logs, program information and access to the educational website;
- G. Secure a release form from participants for the use of their stories, measurable outcomes and any other related matters that may be used for media coverage or testimonials for the FFC program;
- H. If necessary, implement COVID-19 safety measures required by the school district/facility

This term for this MOU is March 26 - August 31, 2021.

If modifications are necessary to complete this agreement, they will be added to this MOU by mutual consent of all parties involved.

We hereby agree to this MOU and certify that agreements made here will be honored.
