TEA MONITOR REMARKS/REPORT

Dr. Abe Saavedra, TEA Monitor: Just some quick comments, this is a budget workshop and the reason I wanted to make some remarks today is that previously some Board members, not necessarily you folks but some Board members, have criticized the Administration that not enough information was provided concerning finances, we didn't know about the deficit until way late, all that kind of stuff. These are the meetings where you as Board members need to be asking questions. It's your responsibility as Board members as fiduciaries for the district to be responsible. If you don't understand something, and let me tell you school finance is difficult to understand, so there's no shame in asking questions so I would encourage you to really understand your budget as you discuss it today, so when you come back to vote, I guess next week, you're well prepared. Henry Yzaguirre, Superintendent of Schools, addressed the Board and audience regarding our Back to School Bash that provided immunizations, school supplies and haircuts. He thanked the staff for putting that together. He said that our Convocation was last week and he thanked Trustees Lopez and Flores for attending. He stated that today was the first day of school. He shared that last year's enrollment on the first day was at 6,466 and today 6,903 showed up. He said that increase is a very

good sign. He thanked the district staff that have put in efforts to recruit and reaching out to our community.
