- Regular bills paid through August 15, 2025 totaled \$1,467,257.90. Motion by Taubert, second by Fruechte, approved payment of the regular bills. Motion carried unanimously.
- ➤ High school activity bills paid through August 15, 2025 totaled \$5,594.53. Motion by Wiese, second by Fruechte, approved payment of the high school activity bills. Motion carried unanimously.
