Administration recommends the Board approve the attached resolution which commits funds for the following:

RATIONALE:

Committed fund balance constraints the use of funds imposed by the Board of Trustees which can be removed or changed only by taking same action, by resolution. Action to constrain resources should occur prior to end of fiscal year, August 31, 2011. The exact amount(s) may be determined subsequently.

BUDGETARY INFORMATION:

\$8,100,000 will have to be re-appropriated for their intended use through a budget amendment from fund balance in 2011-12. The projected August 31, 2011 unassigned fund balance is expected to be \$ 59,676,251.
