

SITE PLAN GENERAL NOTES <u>SITE PLANS</u>

- THE CONTRACTOR SHALL BE RESPONSIBLE FOR EXAMINING ALL SITE CONDITIONS PRIOR TO THE COMMENCEMENT OF WORK WHICH MAY REQUIRE SPECIFIC ATTENTION OR COORDINATION.
- CONTRACTOR SHALL REPAIR OR REPLACE ALL DAMAGED SIDEWALKS, CURBS, OR PAVING AS A RESULT OF CONSTRUCTION ACTIVITIES TO REMAIN IN PLACE.
- NO EXCAVATIONS ARE TO BE LEFT OPEN TO FOUL WEATHER, RAIN, SNOW, ETC.
- . WHICH WOULD NECESSITATE FURTHER EXCAVATION AND ADDITIONAL SUB GRADE MATERIALS.
- CONTRACTOR TO PROTECT NEW AND EXISTING TREES AND LANDSCAPING. CONTRACTOR RESPONSIBLE FOR RESTORING THE SAME.
- THE CONTRACTOR SHALL BE RESPONSIBLE FOR ALL MATERIALS AND QUANTITIES AS REQUIRED TO COMPLETE THE WORK IN ACCORDANCE WITH THE PLANS AND SPECIFICATIONS. THE CONTRACTOR WILL NOTIFY THE ARCHITECT IN WRITING OF ANY DISCREPANCIES OR CHANGES REQUIRED TO COMPLETE THE WORK BEFORE ANY ACTION MAY BE TAKEN. ALL CHANGES OR CHANGE ORDERS MUST BE APPROVED BY THE ARCHITECT AND OWNER BEFORE ANY CHANGES ARE EXECUTED.
- THE CONTRACTOR SHALL NOTIFY J.U.L.I.E. (800-892-0123) 72 HOURS PRIOR TO CONSTRUCTION FOR LOCATION OF UTILITIES AND SHALL BE RESPONSIBLE FOR PROTECTION OF THE SAME.
- THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE PROTECTION OF ALL PRIVATE UTILITIES EVEN THOUGH THEY MAY NOT BE SHOWN ON THE PLANS. ANY UTILITY DAMAGED DURING THE CONSTRUCTION SHALL BE REPAIRED OR REPLACED TO THE SATISFACTION OF THE OWNER AT THE CONTRACTOR'S EXPENSE. NO TREE SHALL BE PLANTED WITHIN 10 LATERAL FEET OF ANY OVERHEAD UTILITY WIRE OR WITHIN 5 LATERAL FEET OF ANY UNDERGROUND WATERLINE, SEWER LINE, TRANSMISSION LINE OR OTHER UTILITY.
- ALL NECESSARY SITE WORK PERMITS AND LICENSES SHALL BE OBTAINED AND PAID FOR BY THE CONTRACTOR PRIOR TO THE COMMENCEMENT OF WORK.
- 0. CONTRACTOR SHALL COMPLY WITH ALL CONSTRUCTION AND DEMOLITION






AREA OF WORK - RUTLEDGE EAST SENSORY PATH 3/8" = 1'-0"






