This upcoming 2023-2024 school year there will be an adjustment to pricing in the Adult/Visitors Meals. The Breakfast and Snacks will show an increase while our lunches will maintain their current rate. The current and proposed charges are as followed:

	2022-2023	2023-2024
Breakfast	\$ 3.00	\$ 3.50
Lunch	\$ 5.00	\$ 5.00
Snack	\$ 1.50	\$ 2.00

The amounts per meals are based on a historical increase for breakfast and lunch which is covered accordingly as per the Adult Meal Calculator Worksheet provided by the Texas Department of Agriculture (TDA). According to the historical yearly increase only our Breakfast and Snacks will need to be adjusted to be in compliance with TDA/USDA guidelines.
