### 1. Coordinator of Compensatory Education Recommendation – Zainab Beydoun

Ms Beydoun started her tenure with the Crestwood School District as a paraprofessional. She has dedicated her career to serving the EL and at risk students in our district. She is passionate and energetic and the committee was able to recognize her drive to advocate for all students. Ms. Beydoun is a SIOP trainer and has worked with Title I,II,III, 31A, Section 41funding and allocation guidelines. She has also served as an EL program coordinator of services at both the elementary and middle school levels. Her average rating was a 3.5/4.0
