District-wide Programming

- Critical Reminder: New board training requirement effective August 1, 2024

All teachers that teach reading have begun the READ ACT training called CAREIALL. This is a gigantic training that requires a lot of time and energy. I thank everyone for their commitment to this! Many teachers attended the Sourcewell Summit at Breezy Point. We had wonderful speakers and received quite a bit of encouragement.

Our enrollment has dropped slightly. We are trying to inquire as to why. Many reasons are taking part in activities that the large districts can offer. Some of the middle school students simply want to be involved where their friends go. This is something we will always see. We are not worried about this, and we also know that our enrollment goes up until mid-October, with fluctuation throughout the year.

Staffing is going very well. We are adjusting as needed. With the drop in enrollment, we may not need as many paras as we have in the past.. We have secured a part time music teacher and full time STEM teacher, however, we are waiting on their licensure approval.
