Dear Ms. Anderson,

On Tuesday April 08, 2025, at 2:00 PM local time, bids were taken for Ryan Intermediate Skylights project. One bid was received from Architectural Glass & Metals at \$399,657.00 base bid. There were four volunteer alternates that were reviewed with district staff. Kingscott met with associated Architectural Glass & Metal and determined that they met the intent of the bid documents.

As a result of the review of the bid alternates district staff are recommending the following Bid Alternates to be accepted in addition to the base bid.

- Bid Alternate No. 1 to add scope and replace (2) 180 degree barrel vaulted canopies. The add costs for this bid alternate is \$21,548.00: Kingscott supports this recommendation.
- Bid Alternate No. 4 to provide .070" White Type A exterior face sheets at Cafeteria and Music Room skylight assemblies as required to match Main Entrance skylight. The add costs for this bid alternate is \$9,611.00. Kingscott supports this recommendation.

Based on our review of the bid form and the result of the post-bid interview, Kingscott associates, Inc. recommends that Gull Lake Community Schools enter into a contract with **Architectural Glass & Metals** for **Ryan Intermediate Skylights project** as outlined in the plans and specifications prepared by Kingscott Associates, Inc. dated March 18, 2025, for the project in the base bid amount of \$399,657.00 and Voluntary Alternate No. 1 of \$21,548.00 and Voluntary Alternate No. 4 of \$9,611.00. **Total award of \$430,816.00.**
