Care Coordination Agreement

This Care Coordination Agreement effective on August 1, 2025, is between <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> and Uvalde Consolidated Independent School District (UCISD) for the purpose of care coordination, streamlining referrals, and maximizing access to community resources by preventing duplication of services.

RESPONSIBILITIES OF: Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC

- ¬Provide patient centered and trauma informed mental health services for youth and families. Services will be rendered at the school setting.
- Refer to outside resources as necessary.
- Provide referrals for UCISD prevention services for at-risk youth and their families.
- \neg <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> agrees to work with UCISD to expedite emergency referrals for students in crisis.
- <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> agrees to coordinate services for families and students of UCISD.
- —<u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> agrees to visit with students/clients during elective classes only unless school agrees to permit student to do so during core class hours due to a crisis or issue of concern.

RESPONSIBILITIES OF UVALDE CONSOLIDATED INDEPENDENT SCHOOL DISTRICT:

- \neg Refer families to <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> who may need mental health services.
- → Uvalde Consolidated Independent School District agrees to coordinate follow up with <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> to facilitate enrollment and engagement of students/families in <u>Counseling Services</u> if needed.
- Uvalde Consolidated Independent School District agrees to coordinate follow up with Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC to the extent feasible, to avoid a duplication of services and agree to share client data as necessary, with appropriate consent.
- Follow up on provision of services.

This agreement between <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> and Uvalde Consolidated Independent School District shall be from August 1, 2021, to July 31, 2026, unless terminated by mutual agreement. Both <u>Let It Bee Counseling Services-Melissa Cabralez M.Ed. LPC</u> and Uvalde Consolidated Independent School District agree to abide by this Care Coordination Agreement, which is not legally binding, but designed to ensure a positive working relationship between both parties.
