Remove the existing fixtures, heads, and cages on the four outside poles. Install Musco LED lighting and cages to the existing poles. Remove the 2 middle poles and dispose of them, leaving the concrete bases in place. Price is based on being able to get the crane and man lift to the poles without having to get on the track. Install Musco controls. The existing breakers, gear, and circuits to the existing poles are to be used.

Sales tax is not included as part of this quote.

## Pricing furnished is effective for 60 days and is considered confidential.

#### **Payment Terms**

Net 30.

Late payment will be subject to service charges of 1 ½% per month (18% APR).

Musco will make every effort to coordinate shipment so that delivery corresponds with the customer's payment schedule. It will be the responsibility of the customer to ensure that Musco is aware of this delivery timeframe. We will expect payment within the terms described above unless there is a written statement from Musco's corporate headquarters stating the acceptance of different terms.

Delivery to the job site from the time of order, submittal approval, and confirmation of order details including voltage and phase, pole locations is approximately 30-45 days. Due to the built-in custom light control per luminaire, pole locations need to be confirmed prior to production. Changes to pole locations after the product is sent to production could result in additional charges.

- Confirmation of pole locations prior to production
- Quote assumes the existing electrical is in good working order.
