The General Funds are State Mandated programs such as Food Services. Most of

the money is in the General Fund (M&O) 97%, Special Revenue fund at 1% and Debt Services Fund at 3%, Special Revenue Fund includes the Food Service Summer Program as required by law, it is a Federal Grant received, it is an entitlement, as the Visually Impaired Program received from the State under Special Education Program, the IMA (Instructional Materials Allotment), and the Elementary Fund these are the Special Revenue Funds, these are funds designated by the State and how it is to be used. Mr. Mijares reviewed the budget groups as required by TEA (General Fund, Debt Services Fund, special Revues fund, and Capital Projects Fund) All school districts in the state of Texas prepare their budgets in this manner. TEA requires all districts to post their budget on district website, excluding the Food Service Program as it audited every year. Our Funding Source of Revenue is 68% from State Funds, 17% Taxes, 13% Federal and 2% from Local Funding. The District is one of the few in the state that have Self-Funding Health Insurance, Workers Compensation and Unemployment. Other budgetary matters included budget assumptions, proposed budget workshop schedule, additional request and other budgetary issues. EPISD has a complete and balanced budget and is a very good budget.

The Audited Beginning Fund Balance is \$51,723,438 and \$11,993,410 from 2021-2022 Esser Estimated M & O Expenditure Reduction. The Estimated Ending Fund Balance for August 31, 2022 should be at \$63,716,848.00. Next year's budget 2022-2023 you see the deduction of the salary increase (estimated Excess (Deficiency) of Revenues Over Expenditure Reduction of \$5,630,817. For the year 2022-2023 we have Esser Estimated M & O Expenditure Reduction of \$7,000,000, we will have a 2022-2023 Estimated Ending Fund Balance August 31, 2023 of \$65,086,031. For the year 2024-2024 we will carry the salary increase Estimated Excess/ (Deficiency) of Revenues over Expenditures of \$5,630,817 and \$7,000,000 in Esser Estimated M & O Expenditure Reduction. Therefore, the Estimated Ending Fund Balance for August 31, 2024 is \$66,455,214.
