Even amidst a pandemic, this has been an accomplished summer here in District 90. Remote Summer School, building construction/renovations, instructional planning, and technology preparations have all played a part in keeping us all busy. I am very proud of the hard work and dedication that everyone has put into ensuring that the summer has been focused and productive.

The Roosevelt HVAC and window replacement projects have obviously been a major focus. Anthony Cozzi and the Building and Grounds team are working very hard to ensure that all of our schools are ready for staff occupancy as soon as possible. All of these efforts are geared toward the official start to the upcoming school year when staff members report to their classrooms and workspaces on Monday, August 24. This day has been designated for teachers to use for working in their classrooms, holding virtual team or articulation discussions, and attending any virtual student-related meetings needed in advance of the first day of "remote student attendance" on Thursday, August 27.

Please see the attached document for guidance on how to self-screen for any potential COVID-19 symptoms when arriving at school and reporting to classrooms on August 24. All individuals working in D90 facilities must wear a mask, adhere to 6-foot social distancing requirements, and comply with frequent hand washing expectations. On August 24, training will be provided to all staff regarding the District 90 safety expectations and procedures. Similarly, you will receive District-issued PPE on the first day of school. Please reach out to your principal if you do not have a mask to wear upon arrival on August 24 or have any questions about entering the building on the first day.

As you can see, there is much to look forward to. Though the challenges are many and varied in our profession, the purpose of our shared work is of the highest calling.
