TOPIC: RECOMMENDATION FOR 2015-2016 MILK BID

BACKGROUND: To comply with the bid law and to obtain the best possible pricing, the District solicits sealed bids for Milk products. Permission to go out for bid was received from the Board on March 19, 2015.

PROCESS: The bid announcement was published on April 23 and April 30. The bid opening occurred on May 20, 2015 at 10:00 a.m. in the conference room at the District Office. Three vendors were contacted to request bids, two vendors responded but only one submitted a bid. The bid was analyzed and a recommendation for award presented to the School Board on June 4, 2015. In general, the ½ pint milk prices are lower than our last formal bid in 2011.

RECOMMENDATION: The administration recommends that the School Board approve Dean Foods, as the vendor for milk for the 2015-2016 budget year based on the Federal Market Escalator pricing.
