RESOLUTION

NON-REEMPLOYMENT OF FIRST, SECOND, OR THIRD YEAR PROBATIONARY TEACHERS

WHEREAS, the teachers hereinafter set forth are first, second or third year probationary teachers employed during the 2013-2014 school term; and

WHEREAS, the Board of Education has determined that these teachers shall be dismissed as of the end of the 2013-2014 school term and not re-employed for the 2014-2015 school term, pursuant to Section 24-11 of The School Code of Illinois (105 ILCS 5/24-11).

NOW, THEREFORE, Be It Resolved by the Board of Education of Oak Park School District 97, Cook County, Illinois, that:

Section 1: The following probationary teachers are hereby dismissed at the end of the 2013-2014 school term:

Section 2: The President and Secretary of the Board are authorized and directed to give the teachers a written Notice and Statement of Non-Reemployment by certified mail, return receipt requested, at least forty-five (45) days before the end of the school term. Section 3: The Superintendent of designee shall also personally deliver a copy of said Notice to the teacher with a signature receipt. A copy of said receipt is attached as Exhibit "B" and incorporated by reference.
