- 1. Call Meeting to Order: After a few board members toured the Tigert Middle School construction, Chairman Lau called the board meeting to order at 7:04 pm. Chairman Lau was joined at the meeting by Vice-Chair Torgesen, Trustee Erickson, and Trustee Kenyon. Trustee Stoor joined the meeting via cellular phone. Also, in attendance were Superintendent Molly Stein, Clerk Jonathan Balls, Principal Jess McMurray, Principal Rod Worthington, Principal Debra Daniels, High School Counselor Chris Ledbetter, two staff members, eight patrons, and six students.
 - **1.1 Approval of Agenda:** Chairman Lau asked if there were any additional agenda items to be added to the posted agenda. An agenda item to hear the Thirkill Elementary mascot change presentation was added as agenda item number three to the agenda. With no further changes brought forth to the posted agenda, Trustee Erickson made a motion to approve the agenda as amended. The motion was seconded by Vice-Chair Torgesen. By a voice vote, the motion passed unanimously.
 - **1.2 Pledge of Allegiance:** Chairman Lau invited the trustees, administration, staff, and students to join Clerk Balls in saying the Pledge of Allegiance.
- 2. Thirkill Elementary Students Mascot Presentation: Six students from Thirkill Elementary School gave a presentation and proposed to change their school mascot from the Thunderbirds to Cardinals. The students had a well scripted presentation, including data from a survey they had conducted. After the board asked questions to the presenters, administration, and parents, Trustee Erickson made a motion to approve the proposal to change the Thirkill Elementary School mascot from Thunderbirds to Cardinals. The motion was seconded by Trustee Kenyon. By a voice vote, the motion passed unanimously.
