<b>Action</b>	Consider approving the Harris County Department of Education Interlocal Agreement for Specialized Services Highpoint School (HS) East for the 2025 - 26 school year.
<b>Motion</b>	I move to approve the Harris County Department of Education Interlocal Agreement for Specialized Services Highpoint School (HS) East for the 2025 - 26 school year.
<b>Administrative Recommendation</b>	Administration recommends approving the Harris County Department of Education Interlocal Agreement for Specialized Highpoint School (HS) East for the 2025 - 26 school year.
<b>Authority for this Action</b>	Board Policy, EHBAC(LEGAL)
<b>Goal/Objective Addressed</b>	Student Achievement Crosby ISD will ensure that every student achieves their full academic potential by providing high quality instruction, engaging learning opportunities, and a supportive environment that prepares all learner for success in an ever-changing world.
<b>Background</b>	The district will purchase 20 seats for DAEP placements for Crosby High School students to occupy as needed. Crosby Middle School students will serve DAEP placements on the campus unless the student's behavior meets the criteria for a Highpoint placement.
<b>Staffing Implications</b>	Approval of Harris County Department of Education Interlocal Agreement for Specialized Services Highpoint School (HS) East for the 2025 - 26 school year, poses no additional staffing implications for Crosby ISD.
<b>Budget Information</b>	<p>Approval of the Harris County Department of Education Interlocal Agreement for Specialized Services Highpoint School (HS) East for the 2025 - 26 school year will allow access to the services and supports for secondary students who are assigned to the DAEP.</p> <p>In consideration of the services provided, Crosby ISD will pay HCDE an in-county fee of \$230,000 and any additional fees in the following manner:</p> <ul style="list-style-type: none"><li>• \$11,500 times the number of units purchased. Crosby ISD will be billed twice a year and payment will be due upon receipt of invoice.</li></ul>

	<ul style="list-style-type: none"> <li>• \$185 special education surcharge times the number of enrollment days for Special Education student(s).</li> <li>• \$240 per diem times the number of student(s) in attendance over the number of units purchased (20).</li> </ul>
<b>Impact of this Action</b>	Approval of this action will allow access to the services and supports necessary to educate our Crosby ISD secondary students who have been assigned to a DAEP setting.
