- Install a 60 mil Non-Reinforced EPDM rubber roof membrane loose laid over new ISO
- Install new 1.5" pre-washed river rock ballast at approx. 10 psf
- Install all new 24 Ga. prefinished coping caps (color from standard color chart)
- Clean up and remove all the roofing debris from the job site

- Remove old rock & EDPM rubber
- Add 1 layer of 1 ½" poly ISO over existing insulation
- Install new 60 mill EDPM rubber loose laid ballast system over the new 1 ½" ISO insulation
- Flash in all curbs and pipes per manufacturers specifications
- Install new ¾" to 1 ½" washed smooth river rock at 10 lbs. per square foot
- Install new parapet coping 24 gauge around all parapets
- Clean up all old material from jobsite
- 15 year manufacturers warranty
