RESOLUTION CANVASSING RETURNS OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION

BE IT RESOLVED by the School Board of Independent School District No. 877, State of Minnesota, as follows:

- 1. It is hereby found, determined and declared that the special election of the voters of this school district held on November 5, 2019, was in all respects duly and legally called and held.
- 2. As specified in the attached two (2) Abstract and Return of Votes Cast, at said election a total of 7263 voters of the school district voted on the question of **increasing** the referendum revenue authorization of the school district for taxes payable in 2020 and thereafter (SCHOOL DISTRICT QUESTION 1), of which 4233 voted in favor, 3030 voted against the same, and there was 1 completely blank or defective ballots. Said proposition, having received the approval of at least a majority of such votes, is hereby declared to have carried.
- 3. The clerk is hereby directed to certify the results of the election to the county auditors of each county in which the school district is located in whole or in part. The clerk is also directed to report the results of the referendum revenue authorization election to the Commissioner of Education within fifteen (15) days of the date hereof.
