Javier Montemayor - Will we be having a Budget Workshop?

Roberto J. Santos – Yes, we will be having a Budget Workshop the beginning of August. Board Members have directed us to look at our Fund Balance and ours is going to be very difficult this year. We need to know that we will be ready for next year as well. We will look at the monies that we have and if there is anything we can do for our employee's definitely we will do it. This will allow us one or two weeks for Laida and her staff to look at the final numbers in this budget. This will give us an idea where we stand. I know we will be short 30M. We need to make sure that we have enough funds to carry us for the next two year and No employees will be hurt. We will look at that and come to the Board with that information. Judd Gilpin – This reminds me of the cuts we went through with the state and it actually worse because it seems so recent we went through those cuts. The other thing that makes it worse right now is that those cuts were a onetime cut. Once we experience those cuts we could move on. This cut will have a more lasting impact. All that being said, I think your suggestions to revisit this at a Budget Workshop is good and much the same as we did that time.

Javier Montemayor - Either that or remove K & L until after the Budget Workshsop.

Roberto J. Santos – Even if we approve tonight K & L and we do find some funds we can some back and re-modify and re-adjust and bring these two items back. As we look at new employees coming in we need to have a set table.

My recommendation tonight is to approve K & L and move with that. This will allow us some time to come to the Board with a Board Workshop.

- David Perez Asking the Board for an increase in pay if possible. He said he does not want to drain the fund balance and does not want any layoffs.
