WHEREAS, the Board of Education (the "Board") of Community Unit School District Number 191, Mason and Tazewell Counties, Illinois (the "District"), by resolution adopted on the 19th day of November, 2025 (the "Bond Resolution"), did provide for (i) the issue of General Obligation School Bonds, Series 2025 (the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds and (ii) the establishment of a bond fund for the repayment of the Bonds (the "Bond Fund"); and

WHEREAS, the Board has determined that the District has lawfully available funds in the Bond Fund in the amount of \$150,000.00 (the "Available Funds"); and

WHEREAS, the Board has further determined that it is necessary and in the best interests of the District to apply the Available Funds to the payment of the Bonds and abate a portion of the tax heretofore levied for the year 2025 to pay the Bonds:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 191, Mason and Tazewell Counties, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Abatement of Tax. A portion of the tax heretofore levied for the year 2025 in the Bond Resolution is hereby abated, as set forth in Exhibit A attached hereto and made a part hereof.

Secretary of the Board shall file a certified copy hereof with County Clerks of The Counties of Mason and Tazewell, Illinois (the "County Clerks"), and it shall be the duty of said County Clerks to abate said tax levied for the year 2025 in accordance with the provisions hereof.

Section 4. Effective Date. This resolution shall be in full force and effect forthwith upon its adoption.
