I. Roll Call, Establish Quorum, Call to Order

Ramiro Veliz, III, board president, called the meeting to order at 6:00 p.m. and stated a quorum of board members was present.

I. Roll Call, Establish Quorum, Call to Order

Mr. Ramiro Veliz, III, board president called the meeting to order at 12:00 p.m. and stated that a quorum of board members was present.

II. Pledge of Allegiance

A. Honor the Texas Flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible.

Mr. David Gonzalez asked for a moment of silence in remembrance of the one-year anniversary of the Uvalde, Texas massacre.

III. Public Comments:

Comments shall be limited to current Board agenda items, student recognitions, or charitable causes. Comments are limited to three minutes per speaker, except that non-english speakers requiring a translator, are limited to six minutes. The presiding Board officer may modify of waive these time limits as appropriate. Public comments shall not be used for personal attacks or use insulting, profane, threatening or abusive language during any Board meeting shall be ruled out of order by the presiding Board officer and may be escorted from the Board meeting room by District peace officers or security staff. Any concerns or complaints regarding individual District employees, students, or parents must be resolved via appropriate complaint process, as stated in Board Policy BED (LOCAL). Pursuant to Section 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public about an item that is not listed on this agenda, unless such response is a recitation of District policy or a statement of specific factual information.

Jose Ovando stated he was there as a parent. Mr. Ovando demanded that the board act with ethics and set aside any personal benefits or anything else they are gaining from this. He asked them to remember that it is our kids whose lives are at stake here and they are here for the children and not for any personal benefit.

Guillermo "Memo" Castro stated he was a graduate of United in 1972. Mr. Castro addressed the board and stated that before them, there were people who sat on that board that brought integrity and dignity to the board. He added that recently there have been some incidents that have happened and that they must act in the best interest of the board. He added that he had just been to his grandson's graduation at Nye Elementary School and he was proud of his grandson and of the school which was the first school that was built. He also stated this building was built by the building trades schools in 1969-70 by Mr. Salas. Mr. Castro stated that in this floor, in this school, we have a tradition of dignity, and integrity to stand up. He told the board they hold the dignity and integrity in their hands and added that in order to move this district forward they have to lead by example. Mr. Castro then addressed Mr. Rodriguez and asked him to do the right thing; to stand down in order to move forward; if not, he and other parents will unite and petition a call back.

IV. Action Items:

A. Discussion and possible action by resolution of the United Independent School District's Board of Trustees to call for the recall of the United Independent School District's member on the Webb County District Board of Directors and to cast all of United Independent School District's 1,066 votes to recall Ricardo "Rick" Rodriguez, the United Independent School District's member on the Webb County Appraisal District Board of Directors, as per section 6.033 of the Texas Property Tax Code

Stephen Trautmann stated he had some information to share with the board. He stated that Mr. Rodriguez had reached out to him regarding his Webb County Appraisal District Board appointment and his presence at District facilities and events. He said that Mr. Rodriguez informed him that he will voluntarily refrain from visiting District facilities or attending District events with the exception of board meetings and in his capacity as a parent, until August of this year and additionally Mr. Rodriguez will voluntarily refrain from attending Webb County Appraisal District board meetings until August of 2023.

Aliza F. Oliveros asked if they can act based on the wording of this item.

Stephen Trautmann stated that the item before them is to pass a resolution which is required by law to recall the votes in the event the board wants to replace Mr. Rodriguez on the Appraisal District. He explained that if they are in favor of that, they would make a motion to approve the resolution or if they want to take no action, they can also do that based on Mr. Rodriguez's statement or there were plenty of other options.

Aliza F. Oliveros made a motion for discussion. Motion was seconded by Javier Montemayor.

Javier Montemayor stated that this is something that he doesn't think any of the board members are happy about and he feels for Mr. Rodriguez's situation. He added that he is satisfied with the statement that was submitted to legal counsel and he made a motion to take no action at this time and hope that this gets resolved before August.

Aliza F. Oliveros stated that it must be difficult for Mr. Rodriguez to make a statement and added that this is what she wanted; for Mr. Rodriguez to come forward and take ownership of what happened in his personal life. She added that this had nothing to do with the district, that they are not here to judge anyone. She said there is a judicial system that will work its way through the process that every citizen deserves and is entitled to. Ms. Oliveros said she also is satisfied with that. She reminded everybody that as a mental health professional we need to respect people's personal lives and that's what she feels the board would be doing here as a United board, to support a fellow board member as he goes through this issue legally and personally. She added she will support the motion and asked the public to understand and to remember that there is a legal process that needs to take place and nobody here is acting like judge and jury, just accepting the fact that he's taking ownership and whenever this is resolved they will deal with it at that time.

Michelle Molina stated that it must be difficult for Mr. Rodriguez and no one would like to be in that position. She said they have received a lot of calls and it was exactly what was detailed in the comments to our attorneys and they are respecting those wishes.

Motion was approved by Javier Montemayor, Aliza F. Oliveros, Ramiro Veliz, III, Michelle Molina and Gilbert Aguilar. Mr. Ricardo Rodriguez abstained. Motion passed.

B. Discussion and possible action by resolution of the United Independent School District's Board of Trustees to nominate a candidate for the Webb County Appraisal District's Board of Directors as a result of the recall of the United Independent School District's member and to cast all of United Independent School District's1,066 votes for United Independent School District's new member to the Webb County Appraisal District Board of Directors for the remainder of the 2022-2023 term as per section 6.033 of the Texas Property Tax Code

Mr. Ramiro Veliz, III asked if they need to make a motion for this item.

Mr. Stephen Trautmann recommended a motion for no action.

Motion for no action was made by Gilbert Aguilar and seconded by Javier Montemayor. Motion was approved by Javier Montemayor, Aliza F. Oliveros, Ramiro Veliz, III, Michelle Molina and Gilbert Aguilar. Ricardo Rodriguez abstained. Motion passed.
