## Superintendent Report

- **Up-date** Mr. Dirksen thanked Cynthia Hodgdon for her kind words related to district efforts on vaccinations. He recognized and thanked Erin Stocker for her efforts in organizing this event and work with county health.
- COVID Up-date Morrow County COVID numbers dropped (31 for the last 2 weeks) moving us from Extreme to Moderate Risk.
- **Bussing** We continue to work with Midco Bus in efforts to increase the number of busses/drivers. The district and Midco are currently working together to increase the bonus for new bus drivers.
- Athletics Volleyball, Soccer, Cross Country and Cheer are scheduled to start February 22<sup>nd</sup>. Football is still looking at other options.
- **COVID Testing** The district will begin testing students if they are in school and have COVID like symptoms (rapid test). There will not be regular testing of students.
- **CARES Act II** MCSD funding will be \$1.9 million. We will have until 2023 to spend the funds. Funds must be spent on items that fit under the COVID umbrella. This will help fund the bonus for bus drivers.
- Wheatridge Windmills Thanks to work put in by County Commissioner Jim Doherty, a SIP Agreement with Wheatridge Windmills will mean \$1 million annually for 15 years to Morrow County schools (including Ione) to be spent on STEAM activities.
