Dr Wagner determined that the cause of death was complications of COPD with ASCVD/CHF. The manner is natural.

Dr Wagner determined that the cause of death was acute combined effects of mitragynine, benzoylcegonine and ethanol. The manner is accident.

The attending signed out the death certificate with fractures and manner is natural. Under review to the MEO the death was considered to be related to the fall with injury. Dr Wagner determined that the cause of death was complications of mechanical fall with multiple rib and pelvic fractures. The manner is accident.
04-0109-DC-2024	Alpena	Released to Funeral Home	51/F that had an extensive medical Hx which included ASCVD with CHF and HTN, COPD, Chronic respiratory failure and DM. It was reported that the decedent was seen in the ED with a recent Dx of pneumonia. It was reported that the decedent was having respiratory distress later in the night and was a witnessed cardiac arrest in front of family and was transported to the ED with ROSC. The decedent suffered cardiac arrest again after an extended treatment period. Dr Wagner determined that the cause of death was a combination of ASCVD with CHF and COPD. The manner is natural.

Soon after the female was placed on comfort care. It was reported that the female was transported earlier in the day for a fall with Dx of hip fracture. Dr Wagner determined that the cause of death was complications of a fall. The manner is accident.
