The Board of Trustees of the Midway Independent School District held a meeting on September 16, 2025, at 7:00 p.m. in the Board Room of the Midway ISD Administration Building located at 13885 Woodway Drive, Woodway, TX 76712. 7A. Annual Bilingual/ESL Program Update

7C. List of Library Books for Procurement

In compliance with Senate Bill 13, MISD has adopted a Collection Development Policy that provides guidance for the selection, evaluation, and maintenance of library resources. The Board of Trustees is responsible for reviewing the list of library materials that have been donated or proposed for procurement. Each board member can propose changes prior to board action. The board may approve or reject the recommended materials.

The list of proposed library materials will be available to the public at least 30 days before the board's vote. The posting will be on the Library Services webpage for public review during the 30-day period.

7D. 2024-2025 STAAR Results

The STAAR results for 2024-2025 were compared to the past two years. The data is disaggregated by grade, subject, and performance bands. Midway ISD earned an "A" rating in the state's 2025 Accountability Ratings and continues to perform above the state and region in all subjects. We saw modest gains in most areas and saw gains in the Masters area of performance in many subjects this year.

8. Presentation/Discussion Items

8A. Monthly Finance Report

The Midway ISD financial report for the month of August was presented by Dr. Allen. Current enrollment is down 77 students from the past year which is less than 1% from the prior year. The 10th day enrollment is 8,712 students. Enrollment is used for budgeting purposes and will be updated as data is accumulated throughout the year.

8B. 2024 & 2025 STAAR Results

Dr. Becky Odajima, Assistant Superintendent of Teaching and Learning, discussed the A-F Accountability Ratings for the past two years. The accountability system evaluates districts and campuses across three key domains: student achievement, school progress, and closing the gaps. Dr. Odajima highlighted Midway's areas of excellence and areas for growth, reviewed local school comparison data, and established performance targets for this school year.

8C. District and Campus Improvement Plans and House Bill 3 Update

Dr. Odajima presented the District and Campus Improvement Plan for 2025-2026. Key requirements and procedures call for each school district to have a District Improvement Plan and for each campus to have a Campus Improvement Plan. These plans must be developed, reviewed, and updated every year and approved by the board. The district continues to work toward House Bill 3 goals for literacy, math, and CCMR.

D. Efficacy of Vape Detectors

Paul Offill, Assistant Superintendent for Administrative Services, discussed the efficacy of vape detectors installed at Midway High School and the two middle schools. Vape detectors have been highly effective in reducing vaping-related behavior incidents and deterring students from vaping on campuses. Administrators reported that the devices are making campuses safer and healthier for students.
