3. Approval of Minutes

Member Mandal made the motion, and was seconded by Member Geraghty to approve the February 20, 2018 Facilities Committee meeting minutes.

4. INFORMATION/DISCUSSION: Lincoln Hall Door 1 Canopy Replacement

The Administration recommended that the Facilities Committee support the recommendation to accept Alternate No. 2 for canopy replacement at Lincoln Hall in the amount \$75,247.56. Arcon provided further explanation of the project and provided potential cost savings ideas. The Administration and the Facilities Committee will keep Z3 Solutions informed on updated design and production material necessities.

5. INFORMATION/DISCUSSION: Request to Bid Lincoln Hall Furniture for Phase III

Member Geraghty motioned, and was seconded by Member Mandal that the Facilities Committee support the recommendation to go out to bid for Phase III furniture replacement at Lincoln Hall.

6. INFORMATION/DISCUSSION: Rutledge Hall Phase II Painting
Member Geraghty motioned, and was seconded by Member Vranas that the Facilities Committee support the recommendation to utilize the services of John Moric for Phase II painting at Rutledge Hall in an amount not to exceed \$25,000. Member Vranas confirmed with Bob Ciserella that all Rutledge Hall painting will be completed summer 2018.

7. INFORMATION/DISCUSSION: Update to District Signage - Divine Signs and Graphics
The Administration recommended that the Facilities Committee support the recommendation to update District signage in the amount of \$4,432.50 with the firm of Divine Signs and Graphics. Christina Audisho will work on design to condense text before Administration approves signage.

Bob Ciserella recommended, and the Facilities Committee approved, changing the next Facilities Committee meeting date from April 17 to April 24, 2018.

9. New Business
Grand Stage Chicago will provide a \$26,550 credit relating to the theatre curtain for Lincoln Hall East Gym renovations.
