

**MINUTES

**Interview of Candidates for Board Trustee Appointment** President Scheel described the selection process for the appointment of a Board trustee. Candidates were then interviewed one at a time. President Scheel announced that **Christopher Boloven**, the seventh candidate Board members selected to interview, was unable to appear before the Board. Mr. Johnson and Mr. Oke then relayed to Board members the questions and answers from their individual phone interviews with Mr. Boloven.
