Dear Dr. Chávez,

I am requesting an update and schedule regarding the RFQ that was approved by the Board for Board Attorney. Please provide the current status, including timelines for review, evaluation, and expected Board presentation.

Additionally, I have been informed that the Procurement Department has extended the purchase order for O'Hanlon in the amount of \$200,000.00 without Board approval. As you are aware, Board Policy CH (Local) requires that all contracts and purchase orders exceeding the procurement threshold, or any amendments/extensions that materially change the value of such contracts, be brought before the Board for approval. Extending this purchase order without Board authorization raises compliance concerns with our adopted policies and with applicable state law governing school district procurement.

To ensure transparency and accountability, I am requesting that all supporting documents be provided, including but not limited to:

The RFQ file and related communications.

The purchase order extension paperwork.

Procurement department correspondence or approvals related to this matter.

I am also requesting that this item be placed on the next Board agenda for discussion and review in order to ensure compliance with Board Policy CH (Local), CH (Legal), and any applicable provisions under the Texas Education Code relating to procurement and Board oversight.
