A. Truth in Taxation, Gary Kawlewski, Director of Finance and Operations
Biggest impact will be LTFM formula allowance increase from \$292 to \$380 per

pupil unit which could generate approximately 2.255 million for fiscal year 2019. Second is the new School Building Bond Ag Credit which will provide a credit for the property owners who have more than one acre of land and we will receive those funds instead from the state. We will again seek to under levy in the debt service fund to spend down its fund balance. Recommendation will be to approve the "maximum" levy in September.
