




#1 & #2: Adjust the alignment of both football field uprights.

- Ensure both uprights are perfectly vertical
- Check for tilt or lean in the uprights
- Realign the uprights to be straight and parallel to the end zone

#3 & #4: Finalizing North End zone area.

- Finished stone is currently being compacted and proof rolled
- Minor grade adjustment underway, and final section nailer board installation in progress















#5: Current field conditions

#6 - #8:Turf Installation Underway

- Currently laying down and installing turf panels
 In the process of cutting and installing field lines, yard markers, logos, and field yard numbers













#9: North end of the stadium - Side Ramp

- Formwork and rebar supports have been set
- Ready for concrete pour once the weather permits

#10: North end Trench Drain

Final section of trench drain is ready for installation as soon as the weather permits

#11 & #12 North and South End Zone Pavement Areas

- Concrete has been poured behind both end zones
- Ensure positive drainage is maintained and address any low spots as needed














#13 & #14: New fence & gates

- New fence posts are in place
- Gates and chain-link mesh need to be installed
- Coordinate with BISD for the final gate locations before installation

#15 & #16 North and South End Zone CMU wall and Netting System

- Eye bolts are being installed on CMU walls for netting tie-down
- Netting poles are in place
- Netting to be installed after the CMU walls and capstones are painted

#17: Turf Infill Materials

- Infill materials are on-site.
- Installation will begin after turf installation is completed

#18: New and Existing Concrete Flumes / Trenches

- Clean and remove all debris from all concrete flumes and trenches
- Ensure positive drainage is maintained

#19 & #20: Debris / Disturbed Areas

- Remove and dispose of all construction debris and dirt piles
- Restore all disturbed areas to equal or better condition



Structural Items

o Install CMU grout fill at both North and South netting walls

Windstorm Items

- o Finalize installing masonry veneer at North netting wall
- o Install cast stone cap at both North and South netting walls
- o Install netting at both North and South netting posts
- o Install all four security light poles
- o Install both North and South game clocks

Windstorm Submittals

- o Security Lighting and Pole Resubmittal (just received this afternoon)
- o Daktronics Time Clock Resubmittal
